INFORMATION

Hampstead Golf Club (HGC) prides itself on being a friendly and inclusive club with a unique club layout that encourages all members to mix with one another for the enjoyment of the sport and its social activities. HGC is the closest golf club to the centre of London and was founded in 1893.

The club is one of the oldest nine-hole suburban parkland courses in England and is situated very close to Hampstead Heath.

The course measures 5,822 yards for men (SSS 68) and 5,368 yards for ladies and juniors (SSS 71) and regularly stages prestigious county tournaments and pro-am events.

It is a private members club that welcomes green fee golfers and all enquiries for new members, ranging from experienced players to relative newcomers. The club is owned by the membership and run by a general manager and an annually elected committee.

All members are encouraged to take part in both the golf and the social elements of the club. As well as many individual, pairs and team golf tournaments for men, ladies and juniors, there is a wide variety of clubhouse activities ranging from a Burns Night and annual quiz evening to a summer family BBQ and Christmas party.

PROSPECTIVE MEMBERSHIP DETAILS

The process for membership is usually quite quick and simple, even though it may at first sound complicated. Plus, it is aimed at ensuring that both the club and the new member eventually enjoy a long and rewarding relationship.

The six-stage membership procedure:

1. Potential new members fill in the application form;
2. A membership committee then considers the applicant's details;
3. Candidates are asked to attend an informal interview with a small number of club members;
4. Nine holes of golf are arranged with the prospective member and other members to establish golfing ability and knowledge of etiquette;
5. Assuming the golf get-together is positive, a nomination-for-membership form is filled out and placed on display in the clubhouse for all members to see;
6. Complete details of the candidate are put to the Captains Committee that makes the final decision on the application.



If your application is successful, a letter of acceptance and fees invoice is sent immediately to complete the process and membership formally begins upon payment of the full amount due.

New members pay an entrance fee equal to two annual subscriptions of the category which they join (*) plus an initial annual fee that will vary according to the month of joining (ie a proportion of the remaining financial year October to September).

Young Adults aged 30 to 34 pay an entrance fee equal to one annual subscription.

Note: * The entrance fee payment may be spread over three years.

Annual Membership Fees update as per website
(as from 1 October 2023)

Adult, Full Membership	£1,650
Young Adult (aged 18-34)	£700 - £1,650**
Junior (aged 12-17)	£400

England Golf & Middlesex County Affiliation Fees are included in your subscription.

Note: ** New young adults pay a graduated scale of fee depending on their age (up to 29 years old); there is also a 50% discount for full-time university students outside London.

Please note that if the application for membership is unsuccessful then a letter from the club stating this outcome will be sent as soon as possible.
